Thank you for your interest in seeking nomination as a Director of SaskCanola. Every registered canola producer is eligible to hold office as a Director on the SaskCanola Board. A registered producer is any producer who has sold canola in either of the previous two crop years (August 1, 2018 to July 31, 2020), and has not requested a levy refund in the past year.

To be nominated, the support signatures of **five registered** producers are required on the Nomination Form. For each of these signatures, we also require: the name under which the canola was sold and the address of the nominators in order to verify their registered producer status. In case you are unable to determine if your five nominators have registered producer status, two extra spaces have been provided on the nomination form.

The Designated Representative Appointment Form must be completed by the candidate and by each producer signing to support the nomination should you or any of the supporting producers sell under a farm name, corporation, partnership, association or society. Please note that the Designated Representative Appointment Form does not need to be completed if the producer sells under his/her personal name.

The Nomination Form and the Candidate Profile Form along with the Designated Representative Appointment Form (if required) must be completed and received by the Returning Officer on or before **4:00pm CST, Friday, September 18th, 2020.**
